



NOTICE IS HEREBY GIVEN THAT a Special Meeting of the Edinburg Economic Development Corporation (EEDC) Board of Directors has been set for the 5th of June, 2019, at 12:00 p.m. at the Edinburg City Hall, located at 415 West University Drive, Edinburg, Texas to consider the following:

1. Call meeting to Order, Establish Quorum.
 2. Roll Call and Certification of Posting of Meeting.
 3. Presentation of North Park Project plans and specifications and consider authorizing staff to go out for bids.
 4. Discuss and consider approval of an Agreement for Realtor Services.
 5. Discuss and consider approval of an architectural firm from the EEDC pool of architects for Professional Services regarding the El Tule Project.
 6. Discuss and consider approval of an architectural firm from the EEDC pool of architects for Professional Services regarding the Workforce and Training Center.
 7. The EEDC Board will convene in Executive Session, in accordance with the Texas Open Meetings Act, Vernon's Texas Civil Statutes Annotated, Government Code, Chapter 551, Subchapter D, Exceptions to Requirements that Meetings be Open, to deliberate under the following Sections:
 - Section 551.071, Consultation with Attorney; and,
 - Section 551.087, Deliberations Regarding Economic Development Negotiations.The EEDC Board may elect to go into Executive Session on any item whether or not such item is posted as an Executive Session item at any time during the meeting when authorized by the provisions of the Texas Open Meetings Act.  - C. Deliberate the possible action regarding First Hartford Realty regarding the restaurant plaza; and,
